2014 STATE B-C STATE TENNIS TOURNAMENT INFORMATION

from the 2013-2014 Post Season Tennis Procedures Manual

AWARDS: The Awards Ceremony will follow the conclusion of the championship matches, including consolation rounds. If a team would like to leave early, they will not be involved in the awards ceremony.

All trophies and medals are provided by NorthWestern Energy. Trophies will be presented to both boys' and girls' teams for 1^{st} , 2^{nd} , and 3^{rd} places. Individual medals will be awarded to each of the top six place winners in both singles and doubles.

- **COACHES MEETING:** Wednesday, May 21, 2014 7:00 PM Loyola Sacred Heart HS Auditorium, 320 Edith Street, Missoula Meet tournament officials and other coaches. Pick up team packets. Discussion of tournament venues and tournament rules/guidelines. Food and Drink will be provided

DRUGS AND ALCOHOL: The MHSA prohibits any use and/or possession of tobacco, alcohol or other mood altering drugs during competition. Violation will cause the coach or participant to be disqualified from fur participation in that event.

FEATHERS WORN IN HAIR: Below is how we will interpret feathers, tinsel, or beads that are worn in the hair. We will treat this type of hair device very similar to the NFHS Volleyball Rules. Under NFHS Volleyball Rule 4-1-5 "hair devices made of soft material and no more than 2 inches wide may be worn."

- The rule does not specify the device must be used for hair control.
- The feather or tinsel cannot be wider than 2 inches. Length is not addressed in the rule. Most of these will not exceed a width of 2 inches.
- Items that fall within the rule would have to be considered in context with the rules.
- If an item presents a problem falling out (beads), USTA rules will be followed.
- If the item is inappropriate by sportsmanship standards prohibit the item from being worn.
- Hard and unyielding items being worn are prohibited.
- HAIR CONTROL DEVICES: Hair devices made of soft material or unadorned hair devices, such as bobby pins, barrettes, or hair clips, no longer than 2 inches, may be worn to control a player's hair. Hair adornments made of soft material and no more than two (2) inches wide may be worn.
- JEWELRY POLICY: No jewelry, which includes visible body piercing objects, shall be worn in any sport. Any piece of jewelry that is visible at the start of or during a contest is a violation of the MHSA Jewelry Policy. Religious medals must be taped to the body and under the uniform. Medical medals must be taped to the body so they are visible.

If a competitor is observed wearing jewelry during the competition the competitor, without delaying competition, shall remove the jewelry before any further competition. If it can't be removed, the competitor will not be allowed to compete until he/she is legally equipped. The tournament manager shall record the name of the competitor, school, event, time the violation occurred and description of prohibited item. The tournament manager shall then notify the head coach of the offending school of the violation. The tournament manager will keep track of the competitor, school, gender and time of day the warning was given. Any further violations of wearing jewelry by that member of the team shall result in disqualification of the competitor from the event. The tournament manager may exercise some discretion when a new violation is reported within minutes of the team warning being issued.

MEDICAL INFORMATION AND MEDICAL TIMEOUTS:

- In the event of injury, the player must be able to play within 15 minutes or the opponent may win by default.
- The time starts when trainer or coach arrives at site.
- A maximum of 5 minutes for both the diagnosis and treatment, treatment will not exceed 3 minutes
- Bleeding timeout treatment time ends when bleeding has stopped and playing area has been cleaned. Maximum amount of treat time is 15 minutes for bleeding

SUBSTITUTES:Because of injury, illness or other emergency situations, one boy or one girl, who was named as an
alternate before the start of the competition, may be used as a substitute before or during the state meet
for DOUBLES PLAY ONLY. this substitute can only be placed at the beginning of a match. This substitute
can be the alternate that was listed for doubles at the divisional tournament or a team member that
participated in the divisional tournament on a doubles team that did not qualify for state.

- **TEAM AREAS:**If you set up an area for your team, please have someone in attendance to watch over personal/teamitems. Please police your area for trash at all times and check closely before your departure each day for
personal/team items. Please respect the facilities that we are using.
- UNIFORMS:Per MHSA Tennis Rules, Section I, General Rules and Regulations, item 2, which can be found under the
MHSA Uniform/Dress Codes rules in the MHSA Handbook or the attached sheet.

WEATHER:

GUIDELINE ON HANDLING CONTESTS DURING LIGHTNING DISTURBANCES

There is a new lightning policy that has been adopted by many sports medicine groups and governing bodies. The major change is that if **ANY** thunder is heard **OR** a cloud-to-ground lightning bolt is seen, play should be suspended, stands should be cleared, and all should seek shelter. Previously, the recommendation suggested that if there was at least a count of 30 seconds between the thunder and the lightning then the storm is far enough away to not to be of concern. This is NO LONGER considered appropriate or accurate. The consensus is there is no thunder without lightning and vice versa, so if one or the other is noted, both are there.

THIRTY MINUTE RULE: Once play has been suspended, wait at least 30 minutes after the **LAST** flash of lightning is witnessed or thunder is heard prior to resuming play.

We ask coaches at the Playfair Park courts to return to their buses or vehicles with their players to wait during the suspension. At the Peak Racquet Club, coaches and players should take shelter in the club. You will receive an all clear notification from the tournament manager.

B. <u>RAIN DELAYS</u>

Α.

If rain causes a suspension of play, we ask that coaches shelter your players during the delay. Time will be provided to dry courts and short warm up period will provided prior to restarting the match at the point of suspension.

If in the case of an extended lightning and/or rain delay, which will be determined at the coaches' meeting, the tournament managers will discuss continuation of the tournament and the Inclement Weather Format. Coaches will be notified as soon as a determination is made.

C. <u>COMPETITION FORMAT – INCLEMENT WEATHER FORMAT</u>

The tournament has reserved all five of the indoor courts at the Peak Racquet Club in case of inclement weather.

Option 1 – Best of 3 sets

- Sets 1 and 2 regular but each set will be shortened by starting at 2 games each.
- Set 3 will be a 10 point match tiebreaker first to 10 points but win by 2.
- A 120 second set break, if split sets.
- Once a round has started, the scoring format will be the same whether the round is finished inside or outside.
- If indoor courts are being used as part of the regular scheduled play (not because of weather issues), scoring will be the same as the outdoor format.
- Tournament Director can modify to no add scoring if needed.

Option 2 – Ten (10) game pro-set with no add.

D. <u>HEAT RELATED ISSUES</u>

The following guidelines should be instituted by meet management in the following to ensure the safety of the athletes should heat and heat related issues become a factor.

- Time extension on change overs.
- Official/Meet manager may institute periodic timeouts during the match after game points. Length of timeouts will be dependent upon weather circumstances.
- The meet director in consultation with medical personnel will determine the continuation of tennis outside in excessive heat. Matches could be shortened at the conclusion of a round.

2014 STATE B-C TENNIS TOURNEY TOURNAMENT RULES

The game of tennis is for the players. With that spirit in mind the following site rules will ensure equitable and speedy play and will promote good sportsmanship. We have provided these site rules for the convenience of the friends and fans of our tennis players. We want to remind you that these are similar to but not the official set of rules which the coaches and tournament officials have in their possession.

PLAYERS:

- It is the responsibility of the players to report to assigned courts at the proper times. Matches will be played on a next-up basis. If a player is more than 15 minutes late, he/she will forfeit that match unless his/her lateness has been the direct result of a previous match, in which case he/she is responsible to get that word to the tournament official at the site where the match is to be played. The coaches are responsible to assure that players are at the appropriate location at the appropriate time.
- 2. In the event of injury, the injured player must be able to play within 15 minutes or the opponent may win by default. Injury time starts when the coach or trainer arrives on the court.
- 3. **Unsportsmanlike conduct, on site, but not during the match** will be penalized one team point (on the first infraction) and removed from further play (on second infraction).
- 4. **Unsportsmanlike conduct during the match**, will be penalized when observed by a tournament official using the following progression of consequences:

First offense:loss of pointSecond offense:loss of gameThird offense:loss of match

Unsportsmanlike conduct on the tournament site (will be determined by tournament officials) includes, but is not limited to: throwing rackets or any equipment, swearing, intentionally hitting game balls out of the court, being abusive to tournament officials, causing a distraction to other players and fighting.

- 5. All players will adhere to the dress code outlined on page 171 of the MHSA handbook. The consequences for failing to comply with the dress code are outlined in the handbook and will be followed by the tournament officials.
- 6. Warm-ups (to include serving and net play) will be restricted to 10 minutes. Players may prepare for their pre-match warm-up by "loosening up" on the grass adjacent to the courts.
- 7. Servers must call out the game score, **loud and clear**, each time a point is earned. Players receiving serve are expected to aggressively request the server to call out the score if it has not been called out clearly
- 8. Winners of each match must report directly to the scorer's table with the game balls at the conclusion of the match.
- 9. Players call their own games as far as line judging is concerned. Players, only, may initiate requests for the assistance of a site official (line judge, rules or score disputes, etc.). In this instant the player requesting arbitration must leave the court and report to the manager to make this request.
- Should any problems arise, a tournament official may be contacted. The site official will be stationed at the scoring station and an assistant will be roaming the courts. If further remedies are needed the tournament manager may be contacted. Balls must be picked up at the scoring station before the match begins.

COACHING:

- 11. To help speed up the matches, coaching will be permitted during the following time frame:
 - a) 90 seconds will be allowed at change-overs.
 - b) Two minutes will be allowed between Set 1 and Set 2. Players must remain inside the fenced area.
 - c) Ten minutes will be allowed between Set 2 and Set 3. Players must remain at the site, but may leave the court. New balls will be issued for the third set, **if** requested.

12. COACHES ARE EXPECTED TO CONTROL THEIR OWN FANS OR PARENTS AS FAR AS UNAUTHORIZED COACHING IS CONCERNED.

SCORING:

- 13. The tie breaker system in use will be the USTA 12-point tiebreaker system (MHSA Manual, page 143). The player who would have served the next game in succession will begin the tiebreaker by serving one point in the deuce court. The opposing player begins service in the ad court and serves twice. Sides change at 6, 12, 18,... points. The first player (doubles team) to score seven points and lead by two points will be the winner.
- 14. To determine the team scores at the tournament, two (2) advancement points will be given to those players advancing on the championship bracket and one (1) advancement point for those advancing on the consolation bracket. Byes, defaults, forfeits, and disqualifications receive two (2) points in the championship bracket and one (1) point in the consolation bracket. Player receiving byes must win the next round in order to receive advancement point(s). Other points awarded shall be first place 10 points; second place 7 points; third place 5 points; fourth place 4 points; fifth place 3 points; sixth place 1 point.
- 15. The entire tournament will be "2 out of 3 sets match format" unless weather becomes a problem. The decision to modify the format of play will be made by the tournament director.

If we are forced to move the tournament inside and change the format of the tournament, the following will apply: Players who have completed at least one set will complete that match on the (2 out of 3) set-scoring basis. In the event of a rain delay, match scores will continue, but all games not completed will be restarted. The delay decision will be made by tournament manager. If the courts need to be squeegeed when play resumes, a five minute warm-up will be given.

- 16. Players will be granted a maximum of 30 minutes of rest between matches.
- 17. The awards ceremony will immediately follow the championship and consolation matches.

COURT MONITOR:

If you are requested to act as a court monitor, your duties are to provide decisions related only to the remedy asked for by the players involved.

As a linesman you overrule a call only when requested to do so.


If you are requested to monitor foot faults or net violations, you will make the call immediately, as a delayed call will impede the progress of the game.

Please introduce yourself to both players. Remember your purpose is to ease any tensions, not increase them.

Please Note: Court monitors can be called at any time. Please be very familiar with the site rules and especially with the job description given for court monitors. Be sure you have a tournament program with you at all times. The site rules are printed in them and will be strictly adhered to. Follow them closely. Any problems not addressed in the program should be referred to the head official at the site and ultimately to the tournament manager. Thank you so much for your help.








2014 STATE B-C GIRLS TENNIS TOURNAMENT – SINGLES CONSOLATION BRACKET







